

MEMORANDUM OF UNDERSTANDING

THE PARTIES:

- (2) Guru Nanak Institute of Technology (GNIT) having its campus at 37/38, Ibrahimpatnam, R. R Dist. TELANGANA, INDIA. ("GNIT")

PURPOSE:

- 1.3 To provide reference study material and reports to all the participants.
- 1.4 To provide scope for sponsored industrial training to the meritorious students in Garage1 Utility Vehicles Pvt Ltd.


2. Responsibilities of GNIT

- 2.1 To provide accommodation and hospitality to the speakers in a business class hotel ~~minimum three star~~ / college guesthouse.
- 2.2 To settle full payment (INR 1, 00,000/-, One Lac Only) on second day of the workshop.

3. SCOPE OF MoU
