- 2. The **INSTITUTION** proposes for EEE BRANCH projects fee,per candidate depending up on the selected domain.
- 3. If any dispute of any kind whasoever where to arise between **INSTITUTION** and **COLLEGE** authorized **HR** of the **INSTITUTION** may approach the Principal of **COLLEGE**.

TERMS AND CONDITIONS:

- 1. MoU is the collaboration between two parties for mutual benefits.
- 2. MoU stands valid for 5 years from the date of agreement .The collaboration can be terminated from either side with notice period of one month.
- 3. Both parties shall work in synchronization to ensure the successful completion of collaboration.
- 4. Both parties shall provide adequate facilities to the students undergoing training with mutual understanding.

The implementation of this MOU shall be renewed annually and however the MOU will be in force for 5 years from 8-11-2016 to 30-5-2021
