- All the projects will be developed by the students under the guidance of INSTITUTION trainers in the college campus.
- The company proposes for ECE, EEE, CSE & IT BRANCHES projects fee, **per Candidate depending up on the selected domain.**
- If any dispute or difference of any kind whatsoever where to arise between INSTITUTION and COLLEGE, authorized HR of the INSTITUTION May Approach the Managing Director of COLLEGE.

The implementation of this MOU shall be renewed annually & however the MOU will be in force for 5 years.
